Due to COVID restrictions Tulsa Girls Art School provided art projects and communications virtually this year, delivering supplies, snacks and instructions to about fifty students. In collaboration with other community organizations, the students created outdoor art installations. Outdoor get-togethers were organized involving art activities and food, safely held in accordance with CDC guidelines.

In addition, art supplies were made available at specified times for the students to pick up.

Normal activities including indoor art instruction, visits to museums and galleries, as well as out of town trips, were suspended due to the pandemic.

Tulsa Girls Art School's mission: Through art, Tulsa girls overcome barriers and discover life-changing purpose, power and possibility!

The Art School began in 2007 with the original purpose of providing an after-school program in a safe, encouraging and instructive environment for underprivileged girls to develop their artistic ability and to eventually teach them the basics of business and money. The organization has evolved and grown, and although the original purpose remains and art is still the medium, the program has expanded to serve the whole girl as expressed by its mission statement. Some students may become successful artists and some will prosper in other areas as the program teaches critical thinking, artistic and social skills, discipline and financial management to help them succeed in life.

The school welcomes girls from third grade through twelfth grade, allowing some students to have nearly ten years of programming and consistent support. All transportation, supplies, space, instruction and snacks are provided free of charge.

In addition to local outings, the older students take a summer trip where they attend galleries, museums, and fine arts education programs in many different cities. For some, it is the first time to travel outside their neighborhood and new worlds and aspirations are opened to them.

Students prepare art exhibits of their work for the public and receive a portion of their art sale proceeds which is maintained in micro-savings accounts for each.

These exhibits help teach teamwork, organization, finances and social skills, in

The Board of Directors strategic planning session resulted in the development of a pilot program to provide art instruction to younger girls at specific schools that began in 2019. With this effort the program expanded its reach to serve more girls.

The schools served are: Booker T. Washington, Will Rogers, Tulsa School of Arts and Sciences, Edison, Webster, Carver, Sequoya and Emerson.
